



CARSON VALLEY CLAYS TRAP AND SPORTING CLAYS LLC RELEASE, WAIVER, INDEMNIFICATION, HOLD HARMLESS, AND ASSUMPTION OF THE RISK AGREEMENT (2 pages)

WHEREAS, in consideration of the use of the (shooting ranges, also known sporting clays fields, two 5 stand fields, trap and skeet fields) and facilities operated by Carson Valley Clays, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Undersigned agrees to the following:

Initial: _____ The Undersigned hereby acknowledges and agrees to have voluntarily applied to use the sporting clay, 5 stands, skeet, trap, and also known as the (shooting ranges) and facilities operated by Carson Valley Clays. It is understood and acknowledged that the use of all facilities (shooting ranges) in which others, as well as the Undersigned, are engaged in any shooting activities involves inherent extreme hazards, dangers, and risks. The Undersigned represents that he/she is physically able, emotionally stable, and fully competent to participate in training and shooting activities and that he/she freely, knowingly, and voluntarily assumes the risks of participating in such activities, including the risks of property damage, bodily harm, and death.

Initial: _____ The Undersigned acknowledges, understands, and agrees to follow all (shooting ranges, trap, skeet, 5 stand, sporting clays) and facilities rules and directives. User acknowledges the access road's hazardous conditions (unpaved, uneven, potholes, debris, weather issues) and voluntarily assumes all associated risks, including property damage or injury. The User waives and releases the Facility and its representatives ("Releasees") from all liability for loss, damage, or injury from using the road. The User agrees to indemnify Releasees against costs incurred due to the User's use of the road and facility. This agreement binds the User's family and representatives. The User understands and accepts these terms.

Initial: _____ The undersigned affirms that he/she will NOT smoke on any shooting range, sporting clay, trap, skeet, pistol and 5 stand or the roads leading to facility, leaving facility, parking areas, and any and all sporting clays course roads. Anyone person(s) who strictly by our observation shall be denied access to any part of the shooting ranges, sporting clays, trap, skeet, five stand and facility.

Initial: _____ The Undersigned affirms that he/she has and will refrain from being under the influence of alcoholic beverages or medications that might impair judgment prior to, and during, shooting sports activities. Further, the Undersigned affirms that he/she understands the possession and influence of unlawful drugs is expressly prohibited on Carson Valley Clays property, and that any person(s) who, strictly by our observations, appears to be under the influence of alcohol or unlawful drugs or emotionally unstable, shall be denied access to any part of the (shooting ranges, sporting clays, trap, skeet, five stands) and facility.

Initial: _____ The Undersigned affirms, under penalty of law and perjury, that he/she can legally possess or rent a firearm and that he/she has no criminal or mental background that restricts the Undersigned from such possession.

Initial: _____ The Undersigned acknowledges that certain ammunition is restricted on this range and that he/she may not use steel or aluminum case, armor piercing, steel core, incendiary, tracer, or reloaded ammunition outside of manufacturers' specifications. If such is used, any damages resulting from such use may be billed directly to the Undersigned.



Initial: _____ In addition, the Undersigned does for himself/herself, and on behalf of his/her heirs, executors, administrators, officers directors, owners, partners, agents, brokers, employees insures, and assigns, hereby releases, acquits, indemnifies, and holds harmless Carson Valley Clays and its heirs, executors, administrators, trustees, officers, directors, owners, partners, agents, brokers, employees, insurers, assigns, and all other related persons, entities, affiliates, predecessors, and successors, from any and all claims, actions in law or equity, causes of actions, demands, rights, damages, costs, loss of services, expenses, and compensation whatsoever arising from any damage to property, injury to person, or death, (whether predicated upon negligence or otherwise) in connection with use of Carson Valley Clays (shooting ranges, five stands, trap, skeet, sporting clays, roads and facilities or participation in any activities therein.) The Undersigned takes full legal and financial responsibility for any damage or harm to himself/herself, and to his/her minor guests, if any, and for damages or harm to other individuals on the premises, rental equipment, or other range equipment that is a result of the actions of the Undersigned and/or his/her minor guests.

By signing this instrument, the Undersigned affirms that he/she has read, understands, and will comply with the requirements as set forth herein, and does hereby agree to defend, indemnify, and hold Carson Valley Clays, its shareholders, officers, managers, assigns, heirs, or employees harmless from any act or omission for which the Undersigned and/or his/her minor guests is/are directly or indirectly responsible. This instrument binds the Undersigned and his/her executors, administrators, assignees or heirs.
